LOS ANGELES REGIONAL INITIATIVE FOR SOCIAL ENTERPRISE (LA:RISE)

An innovative partnership that unites the City and County of Los Angeles workforce agencies with employment social enterprises to help people overcoming high employment barriers get jobs, stay employed, and build a better life. LA:RISE (Los Angeles Regional Initiative for Social Enterprise) connects employment social enterprises to the workforce system, supportive services, and employers, allowing all partners to bring their expertise and resources to the table.

Now in its ninth year, LA:RISE has expanded from 10 to 38 partners across the County of Los Angeles and provided transitional employment to over 7,500 Angelenos.

LA:RISE updates the Housing Resource Guide on an annual basis due to the increasing need to provide housing resources for individuals facing homelessness. For the 1.0 version, LA:RISE staff collected data through resources provided by LAHSA, DPSS, Los Angeles County Housing Resource Center, and other reputable sources. This guide was then reviewed by members from LAHSA, Mayor Garcetti's Office, Enterprise Community Partners, and Century Housing Corporation for accuracy.

While LA:RISE is set-up as a transitional subsidized employment program, we also recognize the value and importance of providing housing resources to program participants. This guide is meant to be a resource that we hope can assist case managers and job developers, as they navigate job options for LA:RISE participants on top of recommending housing options for select individuals.

This guide is not meant to replace the Coordinated Entry System (CES). CES facilitates the coordination and management of resources and services through the crisis response system. CES allows users to efficiently and effectively connect people to interventions that aim to rapidly resolve their housing crisis. This guide is intended to accompany consideration and engagement with CES for those that want to be proactive in taking additional steps to identify housing options.

Financial Assistance

CalWORKS	<p><u>Homeless Assistance:</u> Serves eligible CalWORKs recipients, or apparently eligible CalWORKs applicants, who are homeless or at risk of homelessness. CalWORKs HA can provide payments for temporary shelter for up to 16 cumulative calendar days, as well as payments to secure or maintain housing, including a security deposit and last month's rent, or up to two months of rent arrearages.</p> <p><u>Temporary Homeless Assistance Program:</u> DPSS supplements the State's HA Program, providing an additional 14 days of temporary homeless assistance for CalWORKs Welfare-to-Work (WtW) families enrolled in GAIN or employed.</p> <p><u>Moving Assistance Program:</u> Helps CalWORKs Welfare-to-Work (WtW) families who are homeless or at risk of becoming homeless due to a financial crisis resulting from circumstances out of the family's control. It provides eligible families with a once-in-a lifetime* payment of up to \$2,500 to secure permanent housing.</p> <p><u>4-Month Rental Assistance Program:</u> The County 4-Month RA Program provides formerly homeless CalWORKs Welfare-to-Work (WtW) families with a short-term rental subsidy after securing non-subsidized permanent housing.</p>
GR Housing Subsidy and Case Management Program	<p>The program can provide you with a rental subsidy, move-in assistance, and access to supportive services. COORDINATED ENTRY SYSTYEM

The Coordinated Entry System (CES) for Single Adults, Youth, and Families coordinates supportive services and housing resources across Los Angeles County, to form a collaborative, no-wrong door network that connects homeless individuals and households to services and housing.

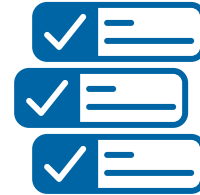
SECTION 8 HOUSING CHOICE VOUCHER



Assists very low-income families, the elderly, and the disabled to afford decent, safe, and sanitary housing in the private market. Since housing assistance is provided on behalf of the family or individual, participants are able to find their own housing, including single-family homes, townhouses, and apartments.

PROJECT-BASED VOUCHERS

The Project-Based Voucher (PBV) Program offers rental housing options at specific housing locations. Assistance is attached to particular rental units, meaning if you live in a rental unit under the PBV Program and move, the assistance stays with the unit.

HOME ENERGY ASSISTANCE PROGRAM

LOW INCOME FARE PROGRAM

Low-income riders can receive additional transit relief with the LIFE Program. The LIFE program offers discounts on select passes or 20 free rides on Metro or any of the participating transit agencies.

METRO MICRO

Micro is Metro's new on-demand rideshare service, offering trips within several zones in LA County. The new service is for short local trips and uses small vehicles (seating up to 10 passengers).

Trips cost only \$1, per ride.

ACCESS SERVICES

ACCESS is a curb-to-curb shared-ride transportation program that is provided for elderly and disabled individuals within Los Angeles County.

Eligible individuals are required to schedule rides ahead of time. ACCESS does not provide emergency or same day transportation services. Most ACCESS rides are shared with other ACCESS riders.

JOB ACCESS PROGRAM

Our program helps people access transportation to work, job training, and job interviews. Additionally, specific Goodwill® sites will now offer rides for criminal record-expungement services and/or to pick up internet devices donated by Indeed.

REDUCED FARE TAP CARD

Many TAP agencies offer reduced fares for Seniors, persons with a disability, and students. For students, Your school must be located in Los Angeles County to apply. Students who meet the minimum enrollment requirements may apply online any time during the current school term.

Housing Rights and Protections



Housing and Employment Discrimination

California's Fair Employment and Housing Act (also known as FEHA) applies to most providers of housing and services related to housing such as landlords, tenant screening companies, real estate agents, home sellers, builders, mortgage lenders, and housing authorities. This law prohibits people or entities that provide housing from discriminating against or harassing tenants, homeowners, residents, their guests, housing or mortgage applicants, home buyers, and others.



Fair Housing and Criminal History FAQ

Regulations from the Civil Rights Department address when and how housing providers may lawfully consider criminal histories in order to protect against unlawful discriminations. CRD is providing guidance concerning the use of criminal history by providers or operators of housing.



Inner City Law Center: Tenants Rights Presentations

Inner City Law Center presents to groups of tenants, staff of other nonprofit organizations, and community groups. Presentations on Inner City Law Center services, the Rent Stabilization Ordinance, landlord and tenant rights and responsibilities, what constitutes a habitability violation, how to file complaints with government agencies, lead hazards, and other housing-related issues.

Los Angeles County: Rent Stabilization Program

The Rent Stabilization Program covers the Rent Stabilization and Tenant Protections Ordinance and the Mobilehome Rent Stabilization and Mobilehome Owner Protections Ordinance, which stabilize rents and extend eviction protections for eligible properties. The program also oversees the Rental Housing Oversight Commission which resolves disputes related to the ordinances.



State of California: Civil Rights Department

The Civil Rights Department only investigates employment, housing and public accommodations discrimination and hate violence pursuant to the California Fair Employment and Housing Act (FEHA), Unruh Civil Rights Act, Disabled Persons Act, and Ralph Civil Rights Act. The Department has jurisdiction over both private and public entities operating within the State of California, including corporate entities, private sector contracts granted by the State of California, and all State departments and local governments.
